

ORDINANCE NO. 11551
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY, LOCATED SOUTH OF KALMIA STREET, WEST OF 32ND STREET, NORTH OF GRAPE STREET, AND EAST OF 31ST STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-2A ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0410, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930, AND ORDINANCE NO. 7579 (NEW SERIES), ADOPTED AUGUST 29, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That property in the Park North-East Community, located south of Kalmia Street, west of 32nd Street, north of Grape Street, and east of 31st Street, in the City of San Diego, California, within the boundaries of the districts designated "R-2" and "R-2A" on Zone Map Drawing No. C-422.3, filed in the office of the City Clerk as Document No. 750681, be, and it is hereby incorporated into R-2 and R-2A Zones, as such zones are described and defined by Sections 101.0409 and 101.0410, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, and Ordinance No. 7579 (New Series), adopted August 29, 1957, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
