AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLAN AREA GENERALLY BOUNDED BY INTERSTATE 805 ON THE WEST, ADAMS AVENUE ON THE NORTH, 40TH STREET ON THE EAST, AND EL CAJON BOULEVARD ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930 AND ORDINANCE NO. 12989, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That property in the Mid-City Plan Area generally bounded by Interstate 805 on the west, Adams Avenue on the north, 40th Street on the east, and El Cajon Boulevard on the south, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-442.2, filed in the office of the City Clerk as Document No. 750694, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.


Section 2. That Ordinance No. 12889, approved July 7, 1930, and Ordinance No. 12989, approved October 20, 1930, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
