AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLAN AREA GENERALLY BOUNDED ON THE NORTH BY COPLEY AVENUE AND COLLIER AVENUE, AND ON THE SOUTH BY ADAMS AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13594, ADOPTED AUGUST 15, 1932, ORDINANCE NO. 12889, APPROVED JULY 7, 1930, AND ORDINANCE NO. 12989, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Plan Area generally bounded on the north by Copley Avenue and Collier Avenue, and on the south by Adams Avenue, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-442.2, filed in the office of the City Clerk as Document No. 750694, be, and it is hereby incorporated into R-3A Zone as such is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13594, adopted August 15, 1932, Ordinance No. 12889, approved July 7, 1930, and Ordinance No. 12989, approved October 20, 1930, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
