AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLAN AREA, GENERALLY BOUNDED BY INTERSTATE 805 ON THE WEST, UNIVERSITY AVENUE ON THE NORTH, 40TH STREET ON THE EAST, AND WIGHTMAN STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That property in the Mid-City Plan Area, generally bounded by Interstate 805 on the west, University Avenue on the north, 40th Street on the east, and Wightman Street on the south, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-443.1, filed in the office of the City Clerk as Document No. 750452, be, and it is hereby incorporated into the R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, approved December 22, 1930, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.
