

ORDINANCE NO. 11564

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLAN AREA, BOUNDED BY INTERSTATE 805 ON THE WEST, WIGHTMAN STREET ON THE NORTH, 40TH STREET ON THE EAST, AND LANDIS STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930, AND ORDINANCE NO. 2440 (NEW SERIES), ADOPTED MAY 12, 1942, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Plan Area, bounded by Interstate 805 on the west, Wightman Street on the north, 40th Street on the east, and Landis Street on the south, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-443.1, filed in the office of the City Clerk as Document No. 750452, be, and it is hereby incorporated into the R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, approved December 22, 1930, and Ordinance No. 2440 (New Series), adopted May 12, 1942, of the Ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith.
