

ORDINANCE NO. 11567
(New Series)

AN ORDINANCE INCORPORATING LOTS 122 AND 123, SAN YSIDRO, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE, AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, a parcel map or maps for lot consolidation is recorded on Lots 122 and 123, San Ysidro, in the City of San Diego, California, within the boundary of the district designated "C-1S" on Zone Map Drawing No. B-2838, the provisions of Section 101.0430 of the San Diego Municipal Code shall attach and become applicable to the land and said land shall be incorporated into C-1S Zone as described by Section 101.0430, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2838, filed in the office of the City Clerk as Document No. 750524. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.


Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 8028 (New Series), adopted December 18, 1958, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.
