AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN LAND IN THE SOUTHEAST SAN DIEGO AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "GRANT HILL PARK."

WHEREAS, The City of San Diego is the owner of certain lands in the southeast San Diego area in the City of San Diego; and

WHEREAS, it is the desire of the people of the City of San Diego to set aside and dedicate forever portions of said lands, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be, and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "GRANT HILL PARK."

Section 3. That the real property so dedicated and named is described as follows:

Lots 21 through 29, Block 40, Mount Gilead, in the City of San Diego, County of San Diego, State of California, according to Maps thereof No. 183 and 445, filed in the Office of the County Recorder of said San Diego County on April 20, 1887.



Section 1. That the hereinafter described real property, to-wit: the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "GRANT HILL PARK."

Section 3. That the real property so dedicated and named is described as follows:

Lot 21 through 25, Block 41, Grant Hill, in the City of San Diego, County of San Diego, State of California, according to the Survey No. 22, 23, 24, 25 and 26, and in the Office of the County Recorder of said San Diego County on April 22, 1978.

Section 4. That the City Clerk of said City be and he is hereby authorized and directed to file a copy of this ordinance in the office of the Recorder of said County of San Diego, State of California, a certified copy of the ordinance.

Section 5. This ordinance shall take effect and be in force on the sixtieth day from and after its passage.
