AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY ESTABLISHING CAPITAL IMPROVEMENTS PROGRAM NO. 36-020 ENTITLED "RECONSTRUCT CENTRAL POLICE LABORATORY - PHASE I" AND TRANSFERRING THE SUM OF \$34,000 FROM CAPITAL OUTLAY FUND (245) RESERVE TO SAID CAPITAL IMPROVEMENTS PROGRAM PROJECT NO. 36-020.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion relating to the Capital Improvements Program by establishing within the Fiscal Year 1975 Capital Improvements Program C.I.P. Project No. 36-020 to be entitled "Reconstruct Central Police Laboratory - Phase I" and transferring the sum of \$34,000 from the Capital Outlay Fund (245) Reserve to C.I.P. Project No. 36-020 for said purpose.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
