AN ORDINANCE PREZONING A PORTION OF THE NORTH-
WEST 1/4 OF THE SOUTHEAST 1/4, SECTION 32,
TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M.,
(SCRIPPS MESA CENTER UNIT 3 ANNEXATION), IN THE
COUNTY OF SAN DIEGO, CALIFORNIA, INTO A-1-1 ZONE
AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO
MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That a portion of the Northwest 1/4 of the
Southeast 1/4, Section 32, Township 14 South, Range 2 West,
S.B.B.M., (Scripps Mesa Center Unit 3 Annexation) in the County
of San Diego, California, within the boundary of the district
designated "A-1-1" on that certain Zone Map Drawing No. B-2835,
filed in the office of the City Clerk under Document No. 750735,
be, upon annexation to The City of San Diego, incorporated
into A-1-1 Zone as defined by Section 101.0404 of the San Diego
Municipal Code.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
