AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED AT THE SOUTHWEST CORNER OF THE INTERSECTION OF JACKSON DRIVE AND PARK RIDGE BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CN ZONE, AS DEFINED BY SECTION 101.0426 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9789 (NEW SERIES), ADOPTED MARCH 28, 1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located at the southwest corner of the intersection of Jackson Drive and Park Ridge Boulevard, in the City of San Diego, California, within the boundary of the district designated "CN" on Zone Map Drawing No. C-435.2, filed in the office of the City Clerk as Document No. 751163, be, and it is hereby incorporated into CN Zone as such zone is described and defined by Section 101.0426 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9789 (New Series), adopted March 28, 1968, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
