ORDINANCE NO. 11581
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED AT THE SOUTHWEST CORNER OF THE INTERSECTION OF MISSION GORGE ROAD AND PRINCESS VIEW DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10291 (NEW SERIES), ADOPTED APRIL 30, 1970, AND ORDINANCE NO. 10770 (NEW SERIES), ADOPTED JANUARY 20, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located at the southwest corner of the intersection of Mission Gorge Road and Princess View Drive, in the City of San Diego, California, within the boundary of the district designated "M-lB" on Zone Map Drawing No. C-437.2 , filed in the office of the City Clerk as Document No. 751164 , be, and it is hereby incorporated into the M-lB Zone as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10291 (New Series), adopted April 30, 1970, and Ordinance No. 10770 (New Series), adopted January 20, 1972, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as the same conflict herewith.
