ORDINANCE NO. 11582 (New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED NORTHWEST OF THE INTERSECTION OF I-8 AND WARING ROAD, AND THAT PROPERTY LOCATED EAST OF WARING ROAD AND SOUTH OF ADOBE FALLS ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CN AND CR ZONES, AS DEFINED BY SECTIONS 101.0426 AND 101.0421.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9632 (NEW SERIES), ADOPTED MAY 25, 1967, AND ORDINANCE NO. 11116 (NEW SERIES), ADOPTED SEPTEMBER 6, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located northwest of the intersection of I-8 and Waring Road, and that property located east of Waring Road and south of Adobe Falls Road, in the City of San Diego, California, within the boundaries of the districts designated "CN" and "CR" on Zone Map Drawing No. C-439.1, filed in the office of the City Clerk as Document No. 750664, be, and it is hereby incorporated into CN and CR Zones as such zones are described and defined by Sections 101.0426 and 101.0421.1, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 9632 (New Series), adopted May 25, 1967 and Ordinance No. 11116 (New Series), adopted September 6, 1973, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as the same conflict herewith.
