

ORDINANCE NO. 11586

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED NORTH OF FRIARS ROAD AND WEST OF MISSION GORGE ROAD, AND THAT PROPERTY LOCATED GENERALLY NORTH OF GLACIER AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA AND M-1A ZONES, AS DEFINED BY SECTIONS 101.0428.1 AND 101.0436, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7226 (NEW SERIES), ADOPTED NOVEMBER 27, 1956, ORDINANCE NO. 8671 (NEW SERIES), ADOPTED JULY 5, 1962, ORDINANCE NO. 8673 (NEW SERIES), ADOPTED JULY 5, 1962, ORDINANCE NO. 10442 (NEW SERIES), ADOPTED NOVEMBER 17, 1970, ORDINANCE NO. 10579 (NEW SERIES), ADOPTED MAY 13, 1971, AND ORDINANCE NO. 10991 (NEW SERIES), ADOPTED FEBRUARY 13, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located north of Friars Road and west of Mission Gorge Road, and that property located generally north of Glacier Avenue, in the City of San Diego, California, within the boundaries of the districts designated "CA" and "M-1A" on Zone Map Drawing No. C-440.2, filed in the office of the City Clerk as Document No. 751169, be, and they are hereby incorporated into CA and M-1A Zones, as such zones are described and defined by Sections 101.0428.1 and 101.0436 of the San Diego Municipal Code.
