ORDINANCE NO. 11587 (New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED ALONG MISSION GORGE ROAD, LOCATED SOUTH OF RAINIER AVENUE AND NORTHERLY OF TWAIN AVENUE, AND THAT PROPERTY LOCATED SOUTH OF TWAIN AVENUE AND EAST OF MISSION GORGE ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7226 (NEW SERIES), ADOPTED NOVEMBER 27, 1956, ORDINANCE NO. 8725 (NEW SERIES), ADOPTED SEPTEMBER 13, 1962, AND ORDINANCE NO. 10991 (NEW SERIES), ADOPTED FEBRUARY 13, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located along Mission Gorge Road, located south of Rainier Avenue and northerly of Twain Avenue, and that property located south of Twain Avenue and east of Mission Gorge Road, in the City of San Diego, California, within the boundary of the district designated C-1 on Zone Map Drawing No. C-440.2 , filed in the office of the City Clerk as Document No. 751169 , and they are hereby incorporated into C-1 Zone as such zone is described and defined by Section 101.0430.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7226 (New Series), adopted November 27, 1956, Ordinance No. 8725 (New Series), adopted September 13, 1962, and Ordinance No. 10991 (New Series), adopted
