AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LYING WESTERLY OF FAIRMOUNT AVENUE, AND BOUNDED BY SAN DIEGO MISSION ROAD ON THE NORTH, AND INTERSTATE 8 ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7226 (NEW SERIES), ADOPTED NOVEMBER 27, 1956, AND ORDINANCE NO. 10141 (NEW SERIES), ADOPTED SEPTEMBER 25, 1969, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME
