ORDINANCE NO. 11590
(New Series)

MAY 8 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA GENERALLY BOUNDED ON THE WEST BY FAIRMOUNT AVENUE, ON THE NORTH BY THE PROPERTY LINE BETWEEN RAINIER AVENUE, AND ON THE EAST AND SOUTH BY MISSION GORGE ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7226 (NEW SERIES), ADOPTED NOVEMBER 27, 1956, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area generally bounded on the west by Fairmount Avenue, on the north by the property line between Rainier Avenue, and on the east and south by Mission Gorge Road, in the City of San Diego, California, within the boundary of the district designated "M-1A" on Zone Map Drawing No. C-440.2, filed in the office of the City Clerk as Document No. 751169, be, and it is hereby incorporated into M-1A Zone as such zone is described and defined by Section 101.0436 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7226 (New Series), adopted November 27, 1956, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.
