AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 10897 (NEW SERIES), ADOPTED AUGUST 24, 1972, INCORPORATING PORTIONS OF LOTS 5, 6 AND 28, EUREKA LEMON TRACT, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE, AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 10897 (New Series), adopted August 24, 1972, be, and it is hereby amended to read as follows:

Section 1. That portions of Lots 5, 6 and 28, Eureka Lemon Tract, in the City of San Diego, California, within the boundary of the district designated "C-1S" on Zone Map Drawing No. B-2635.1, filed in the office of the City Clerk as Document No. 740575, be, and they are hereby incorporated into C-1S Zone as such zone is described and defined by Section 101.0430 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
