AN ORDINANCE AMENDING CHAPTER III, ARTICLE 5,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 35.0101 RELATING TO TRANSIENT
OCCUPANCY TAX.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter III, Article 5, of the San Diego
Municipal Code be and the same is hereby amended by amending
Section 35.0101 to read as follows:

SEC. 35.0101 TITLE AND PURPOSE

a. Title. This article shall be known as
the Transient Occupancy Tax Ordinance of The City
of San Diego.

b. Purpose and Intent. It is the purpose
and intent of the Council that there be imposed
on transient occupants of hotel rooms in the
City of San Diego a tax, the proceeds of which
are to be used for promoting the City of San Diego
including the planning, construction, maintenance
and operation of tourist-related cultural and
recreational facilities, including convention
facilities, and for those additional purposes set
forth in Section 35.0116 of this article.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
