

ORDINANCE NO. 11593
(New Series)

MAY 8 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA, LOCATED ON THE SOUTHWEST, AND NORTHEAST AND SOUTHEAST CORNERS AT THE INTERSECTION OF NAVAJO ROAD AND LAKE MURRAY BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-S ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area, located on the southwest, and northeast and southeast corners at the intersection of Navajo Road and Lake Murray Boulevard, in the City of San Diego, California, within the boundary of the district designated "CA-S" on Zone Map Drawing No. C-434.1, filed in the office of the City Clerk as Document No. 751215, be, and it is hereby incorporated into CA-S Zone as such zone is described and defined by Section 101.0428 of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
