AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA LOCATED ON THE WEST SIDE OF WARING ROAD, SOUTH OF ZION AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 6395 (NEW SERIES), ADOPTED FEBRUARY 3, 1955 AND ORDINANCE NO. 6776 (NEW SERIES), ADOPTED DECEMBER 13, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area located on the west side of Waring Road, south of Zion Avenue, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. C-438.1, filed in the office of the City Clerk as Document No. 750665, be, and it is hereby incorporated into CA Zone as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 6395 (New Series), adopted February 3, 1955 and Ordinance No. 6776 (New Series), adopted December 13, 1955, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
