AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4, SECTION 84.12 OF THE SAN DIEGO MUNICIPAL CODE RELATING TO THE USE OF COASTERS, ROLLER SKATES, AND SIMILAR DEVICES RESTRICTED.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter VIII, Article 4, Section 84.12 of the San Diego Municipal Code be amended to read as follows:

SEC. 84.12 USE OF COASTERS, ROLLER SKATES,  
AND SIMILAR DEVICES RESTRICTED

It shall be unlawful for any person upon roller skates or riding on or by means of a coaster, skateboard, toy vehicle, or similar device to go upon an open roadway in the City of San Diego, or upon the sidewalk or public plaza in any business district, or upon the inclined ramp or other inclined surface area of any city-owned or privately owned parkade where signs forbidding such activity are displayed at the ground level elevator entrance and at each vehicular entrance to the parkade. During the periods when any city-owned parkade is not open for parking purposes, any person, or group of persons, with the prior written consent of the City Manager, may utilize such parkade for skateboard use, subject to such conditions and restrictions as may be imposed by the City Manager.
