AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY 40TH STREET, ON THE NORTH BY UNIVERSITY AVENUE, ON THE EAST BY THE PROPERTY LINE BETWEEN 43RD STREET AND FAIRMOUNT AVENUE, AND ON THE SOUTH BY WIGHTMAN STREET AND LANDIS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930 AND ORDINANCE NO. 3159 (NEW SERIES), ADOPTED APRIL 9, 1946, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:
