

ORDINANCE NO. 11606  
(New Series)

MAY 22 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY 40TH STREET, ON THE NORTH BY UNIVERSITY AVENUE, ON THE EAST BY THE PROPERTY LINE BETWEEN 43RD STREET AND FAIRMOUNT AVENUE, AND ON THE SOUTH BY WIGHTMAN STREET AND LANDIS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930 AND ORDINANCE NO. 3159 (NEW SERIES), ADOPTED APRIL 9, 1946, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area generally bounded on the west by 40th Street, on the north by University Avenue, on the east by the property line between 43rd Street and Fairmount Avenue, and on the south by Wightman Street and Landis Street, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-448.1 filed in the office of the City Clerk as Document No. 751354, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, approved December 22, 1930 and Ordinance No. 3159 (New Series), adopted April 9, 1946, of the Ordinances of The City of San Diego, be, and the same
