

ORDINANCE NO. 11609
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY THE PROPERTY LINE BETWEEN FAIRMOUNT AVENUE AND 44TH STREET, ON THE NORTH BY LANDIS STREET AND WIGHTMAN STREET, ON THE EAST BY EUCLID AVENUE, AND ON THE SOUTH BY LANDIS STREET AND DWIGHT STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057, APPROVED DECEMBER 22, 1930, AND ORDINANCE NO. 5306 (NEW SERIES), ADOPTED AUGUST 28, 1952, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That property in the Mid-City Area generally bounded on the west by the property line between Fairmount Avenue and 44th Street, on the north by Landis Street and Wightman Street, on the east by Euclid Avenue, and on the south by Landis Street and Dwight Street, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-448.1, filed in the office of the City Clerk as Document No. 751354, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, approved December 22, 1930, and Ordinance No. 5306 (New Series), adopted August 28, 1952,
