

ORDINANCE NO. 11611

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY 51ST STREET, ON THE NORTH BY ORANGE AVENUE, ON THE EAST BY 52ND STREET, AND ON THE SOUTH BY UNIVERSITY AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 184 (NEW SERIES), ADOPTED MARCH 20, 1933 AND ORDINANCE NO. 13599, ADOPTED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area generally bounded on the west by 51st Street, on the north by Orange Avenue, on the east by 52nd Street, and on the south by University Avenue, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-449.1, filed in the office of the City Clerk as Document No. 751356; be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 184 (New Series), adopted March 20, 1933, and Ordinance No. 13599, adopted July 11, 1932, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
