AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY WARD ROAD, ON THE NORTH BY ALDER AVENUE, ON THE EAST BY EDGEWARE ROAD, AND ON THE SOUTH BY ADAMS AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 5970 (NEW SERIES), ADOPTED FEBRUARY 18, 1954 AND ORDINANCE NO. 5919 (NEW SERIES), ADOPTED JANUARY 7, 1954, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That property in the Mid-City Area generally bounded on the west by Ward Road, on the north by Alder Avenue, on the east by Edgeware Road, and on the south by Adams Avenue, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. C-447.1, filed in the office of the City Clerk as Document No. 751359, be, and it is hereby incorporated into R-2 Zone as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 5970 (New Series), adopted February 18, 1954 and Ordinance No. 5919 (New Series), adopted January 7, 1954, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
