

ORDINANCE NO. 11616
(New Series)

MAY 27 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA, GENERALLY BOUNDED ON THE WEST BY FAIRMOUNT AVENUE, ON THE NORTH BY MONROE AVENUE, ON THE EAST BY EUCLID AVENUE, AND ON THE SOUTH BY EL CAJON BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12989, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area, generally bounded on the west by Fairmount Avenue, on the north by Monroe Avenue, on the east by Euclid Avenue, and on the south by El Cajon Boulevard, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-447.1, filed in the office of the City Clerk as Document No. 751359, be, and it is hereby incorporated into R-3A Zone, as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12989, approved October 20, 1930, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
