

ORDINANCE NO. 11617  
(New Series)

MAY 27 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA, GENERALLY BOUNDED ON THE WEST BY EUCLID AVENUE, ON THE NORTH BY MONROE AVENUE, ON THE EAST BY ALTADENA AVENUE, AND ON THE SOUTH BY EL CAJON BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7550 (NEW SERIES), ADOPTED AUGUST 15, 1957, AND ORDINANCE NO. 13559, ADOPTED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area, generally bounded on the west by Euclid Avenue, on the north by Monroe Avenue, on the east by Altadena Avenue, and on the south by El Cajon Boulevard, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-447.1, filed in the office of the City Clerk as Document No. 751359, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7550 (New Series), adopted August 15, 1957, and Ordinance No. 13559, adopted July 11, 1932, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.


