AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA GENERALLY BOUNDED ON THE WEST BY 40TH STREET, ON THE NORTH BY ADAMS AVENUE, ON THE EAST BY 42ND STREET, AND ON THE SOUTH BY MONROE AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 5919 (NEW SERIES), ADOPTED JANUARY 7, 1954 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area generally bounded on the west by 40th Street, on the north by Adams Avenue, on the east by 42nd Street, and on the south by Monroe Avenue, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. C-447.1, filed in the office of the City Clerk as Document No. 751359, be, and it is hereby incorporated into R-2A Zone as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 5919 (New Series), adopted January 7, 1954, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.
