

ORDINANCE NO. 11619  
(New Series)

MAY 27 1975

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY AREA, GENERALLY BOUNDED ON THE WEST BY ALTADENA AVENUE AND THE ALLEY BETWEEN 49TH STREET AND WINONA STREET, ON THE NORTH BY MADISON AVENUE AND ADAMS AVENUE, ON THE EAST BY MARCELLENA ROAD AND COLLWOOD GLEN SUBDIVISION, AND ON THE SOUTH BY EL CAJON BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A, R-3, AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0412, 101.0411 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13559, ADOPTED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Area, generally bounded on the west by Altadena Avenue and the alley between 49th Street and Winona Street, on the north by Madison Avenue and Adams Avenue, on the east by Marcellena Road and Collwood Glen Subdivision, and on the south by El Cajon Boulevard, in the City of San Diego, California, within the boundaries of the districts designated "R-3A," "R-3" and "R-2" on Zone Map Drawing No. C-447.1, filed in the office of the City Clerk as Document No. 751359, be, and it is hereby incorporated into R-3A, R-3 and R-2 Zones, as such zones are described and defined by Sections 101.0412, 101.0411 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 13559, adopted July 11, 1932, of the Ordinances of The City of San Diego, be, and the same is


