AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY ESTABLISHING CAPITAL IMPROVEMENTS PROGRAM NO. 34-018 ENTITLED "STADIUM PLAYING FIELD IMPROVEMENTS" AND TRANSFERRING THE SUMS OF \$56,039 FROM CAPITAL OUTLAY FUND (245) RESERVE AND \$20,961 FROM THE STADIUM CONSTRUCTION FUND (950) TO SAID CAPITAL IMPROVEMENTS PROGRAM PROJECT NO. 34-018, FOR THE PURPOSE OF REIMBURSING THE STADIUM OPERATIONS FUND (256).

WHEREAS, the San Diego Stadium field renovation project was charged to the Stadium Operations Fund (256) as the most expeditious manner to meet the contractor's critical sod-growing schedule in order to meet the requirements of the baseball schedule; and

WHEREAS, the field renovation project was approved by City Council Resolution No. 211330, dated August 22, 1974; and

WHEREAS, it is now desired to reimburse the Stadium Operations Fund for the expenditure of funds therefrom for such purpose; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY

Project No. 34-018 to be entitled "Stadium Playing Field Improvements" and transferring the sums of \$56,039 from the Capital Outlay Fund (245) Reserve and \$20,961 from the Stadium Construction Fund (950) to C.I.P. Project No. 34-018 for the purpose of providing funds to reimburse the Stadium Operations Fund (256).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
