AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2,  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 22.0207(c) RELATING TO PARADES.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter II, Article 2, Section 22.0207(c)  
of the San Diego Municipal Code be and the same is hereby  
amended to read as follows:

SEC. 22.0207 PARADES

(c) Parade Prohibited. No permit shall be issued  
authorizing the conduct of a parade which is to be held  
for the primary purpose of advertising any person,  
product, goods, wares, merchandise, or event, and is  
designed to be held primarily for private profit or a  
charitable purpose. Permits will not be approved for a  
parade, if any major portion of the theme of the parade  
is directed at solicitation of funds, sale of merchandise,  
or tickets, or any other exploitation of the crowd.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
