AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 10802 (NEW SERIES), ADOPTED MARCH 16, 1972, AMENDED BY ORDINANCE NO. 11320 (NEW SERIES), ADOPTED MAY 16, 1974, INCORPORATING LOTS 24 THROUGH 37, BLOCK 212; LOTS 21 THROUGH 37, BLOCK 213; LOTS 21 THROUGH 36, BLOCK 214; AND LOTS 5 THROUGH 20, BLOCK 239, ALL IN PACIFIC BEACH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 10802 (New Series), adopted March 16, 1972; and

WHEREAS, said Ordinance No. 10802 (New Series) provided that the CO Zone would attach on the subject property if parcel maps were recorded on or before April 15, 1975; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 2 of Ordinance No. 10802 (New Series), adopted March 16, 1972, amended by Ordinance No. 11320 (New Series), adopted May 16, 1974, be, and it is hereby amended to read as follows:

Section 2. That in the event that, on or before

April 15, 1976, parcel maps for lot consolidation are
recorded on Lots 24 through 37, Block 212; Lots 21 through



37, Block 213; Lots 21 through 36, Block 214; and Lots 5 through 20, Block 239, all in Pacific Beach, in the City of San Diego, California, designated "CO" on Zone Map Drawing No. B-2583, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to the land and said land shall be incorporated into CO Zone, as described by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2583, filed in the office of the City Clerk as Document No. 738916. Said zoning shall attach only to those areas included in the parcel maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
