ORDINANCE NO. 11638

AN ORDINANCE REPEALING ORDINANCE NO. 5032, APPROVED MARCH 12, 1913, DOCUMENT NO. 59295 AND REVOKING PERMISSION GRANTED BY SAID ORDINANCE.

WHEREAS, Ordinance No. 5032, approved March 12, 1913, authorized the construction of a spur track on Eighth Street from K to L Streets; and

WHEREAS, said spur track was removed in May 1972 by the Atchison, Topeka and Santa Fe Railway Company; and

WHEREAS, a \$25.00 fee was payable to The City of San Diego each year the spur track was in place; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the \$25.00 fee payable to The City of San Diego for use of the spur track is hereby terminated as of March 31, 1975.

Section 2. That Ordinance No. 5032, approved March 12, 1913, entitled "AN ORDINANCE AUTHORIZING THE SAN DIEGO ICE & COLD STORAGE COMPANY TO CONSTRUCT A SPUR TRACK ON EIGHTH STREET FROM L TO K STREET, IN THE CITY OF SAN DIEGO," be and the same is hereby repealed in its entirety.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
