AN ORDINANCE AMENDING RULES 1 AND 3 OF SECTION 22.0101 OF CHAPTER II, ARTICLE 2, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE RELATING TO TIME AND CONDUCT OF COUNCIL MEETINGS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Rule 1 of Section 22.0101 of Chapter II,
Article 2, Division 1, of the San Diego Municipal Code be
amended to read as follows:

Rule 1. Hours of Meetings

(a) Regular meetings of the City Council each week shall be as follows:

Wednesday afternoon meeting 2:00 p.m. - 5:30 p.m. Thursday morning meeting 8:30 a.m. - 12:00 noon Thursday afternoon meeting 2:00 p.m. - 5:30 p.m.

- (b) A single docket covering all of the regular Council meetings in any one week shall be published.
- (c) The time of a meeting may be extended beyond the time specified above by two-third (2/3) vote of the members of the Council.
- (d) Regular Council meetings shall be held in the Council Chambers of the City Administration Building, Community Concourse, in the City of San Diego, California. In the event a regular meeting shall fall on a legal holiday, the meeting may be held on the next business day.

MICROFILMED MAY 8 1978 (e) The Council may by resolution, when necessary, change the time and place of regular meetings. The resolution shall set forth the circumstances necessitating such change. Such resolution shall be published once in the City official newspaper at least twenty-four (24) hours prior to the first meeting to be held pursuant to such change. Twenty-four hours prior to the first meeting to be held pursuant to such change, the City Clerk shall give each Councilman written notice, personally or by registered mail, of any change from the regular meeting days established by this section.

Section 2. That Rule 3 of Section 22.0101 of Chapter II, Article 2, Division 1, of the San Diego Municipal Code be amended to read as follows:
