

ORDINANCE NO. 11645 JUL 9 1975
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF LOTS 2 AND 3, BLOCK 4, AND PORTIONS OF LOTS 10-12, BLOCK 3, ROSEDALE, AND A PORTION OF ORANGE AVENUE CLOSED, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP ZONE, AS DEFINED BY SECTION 101.0435.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8660 (NEW SERIES), ADOPTED JUNE 14, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 2 and 3, Block 4, and portions of Lots 10-12, Block 3, Rosedale, and a portion of Orange Avenue closed, in the City of San Diego, California, within the boundary of the district designated "M-IP" on Zone Map Drawing No. B-2857, filed in the office of the City Clerk as Document No. 751401 be, and they are hereby incorporated into M-IP Zone as such zone is described and defined by Section 101.0435.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8660 (New Series), adopted June 14, 1962, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
