ORDINANCE NO. 11646

AN ORDINANCE INCORPORATING LOT 2, PENASQUITOS GREENS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10352 (NEW SERIES), ADOPTED JULY 23, 1970, AND ORDINANCE NO. 10956 (NEW SERIES), ADOPTED NOVEMBER 21, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, Lot 2, Penasquitos Greens, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. B-2858, is subdivided and a final subdivision map or maps thereof duly approved by the City Council and thereafter recorded, and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0407 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R-1-5 Zone, as described and defined by Section 101.0407, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2858, filed in the office of the City Clerk as Document No. 751403.


Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 this ordinance, Ordinance No. 10352 (New Series), adopted July 23, 1970, and Ordinance No. 10956 (New Series), adopted November 21, 1972, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
