AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.06 RELATING TO PARKING, STANDING, LOADING ZONES, AND SECTION 86.10.3 RELATING TO PARKING IN ALLEYS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, Sections 86.06 and 86.10.3 be and the same are hereby amended to read as follows:

SEC. 86.06 PARKING, STANDING, LOADING ZONES

The City Manager is hereby authorized to determine the location of Loading Zones, Passenger Loading Zones, Bus Loading Zones, Taxi Zones, prohibited Standing or Parking Zones, Safety Zones, and Alley Parking Zones. Such zones shall be effective when appropriate signs or curb markings giving notice thereof are erected upon such zones.

SEC. 86.10.3 PARKING IN ALLEYS

Except in Alley Parking Zones as designated and posted pursuant to Section 86.06 of this Code, no person shall stop or stand any vehicle in an alley for a period of time longer than is necessary for the loading or unloading of passengers or materials. Such loading or unloading shall not consume more than three (3) minutes for passengers nor more than twenty (20) minutes for



materials. No person shall stop or stand any vehicle in an alley in such a manner that would prevent the passage of emergency vehicles.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
