

ORDINANCE NO. 11666
 (New Series) AUG 27 1975

AN ORDINANCE INCORPORATING PARCEL 1, PARCEL MAP NO. 3953, BEING A PORTION OF LOT 1, MIRAMAR INDUSTRIAL TRACT UNIT 8, MAP NO. 7573, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10923 (NEW SERIES), ADOPTED SEPTEMBER 14, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 1, Parcel Map No. 3953, being a portion of Lot 1, Miramar Industrial Tract Unit 8, Map No. 7573, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-2855.1, filed in the office of the City Clerk Document No. 752498 be, and it is hereby incorporated into M-1B Zone as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10923 (New Series), adopted September 14, 1972, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as in conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
