AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLANNING AREA III, LOCATED NORTHEASTERLY OF THE INTERSECTION OF 73RD STREET AND EL CAJON BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.
