ORDINANCE NO. 11707
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLANNING AREA III, LOCATED SOUTH AND WEST OF ALVARADO CANYON ROAD, KNOWN AS LOTS 11, 12, 13, 14 AND 15, ALVARADO PLAZA UNIT 3, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That property in the Mid-City Planning Area III, located south and west of Alvarado Canyon Road, known as Lots 11, 12, 13, 14 and 15, Alvarado Plaza Unit 3, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-454.1, filed in the office of the City Clerk as Document No. 751826, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That the following Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
