AN ORDINANCE INCORPORATING LOTS 13 AND 14, GARDEN VILLA TRACT (PALM CITY SANITATION DISTRICT SEWAGE TREATMENT PLANT SITE) IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE, AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING ORDINANCE NO. 7606 (NEW SERIES), ADOPTED SEPTEMBER 26, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Garden Villa Tract (Palm City Sanitation District sewage treatment plant site), located southerly of the S.D. and A.E. Railroad right-of-way and the Otay River, and westerly of Lee Avenue in South San Diego, in the City of San Diego, California, within the boundary of the district designated "A-1-10" on Zone Map Drawing No. B-2804, filed in the office of the City Clerk as Document No. 752630, be, and it is hereby incorporated into A-1-10 Zone as such zone is described and defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7606 (New Series), adopted September 26, 1957, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.
