AN ORDINANCE INCORPORATING A PORTION OF LOT 1, SAMPLE-BROWN TRACT, AND A PORTION OF PUEBLO LOT 1119, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 1947 (NEW SERIES), ADOPTED OCTOBER 1, 1940, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, a parcel map is recorded on a portion of Lot 1, Sample-Brown Tract and a portion of Pueblo Lot 1119, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2872, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to the said land and said land shall be incorporated into CO Zone, as described and defined by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2872, filed in the office of the City Clerk as Document No. 752728.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 1947 (New Series), adopted October 1, 1940, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.
