

ORDINANCE NO. 11712

AN ORDINANCE ESTABLISHING A NEW  
PARKING METER ZONE.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. Pursuant to the authority of Section 22508  
of the California Vehicle Code, and in accordance with the  
provisions of Chapter VIII of the San Diego Municipal Code,  
a parking meter zone is hereby established in the following  
location:

West side of FOURTH AVENUE,  
between Spruce and Thorn Streets.


The above-described meters shall be in parking meter Zone A  
as described in Section 86.11 of the San Diego Municipal Code.

Section 2. A parking time limit of two-hours shall be in  
effect in the above-described location between the hours of  
8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted.

Section 3. The installation of parking meters and the  
necessary signs and markings be, and the same are hereby  
authorized to be made in the above-described location.

Section 4. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
