AN ORDINANCE INCORPORATING THAT PROPERTY IN THE MID-CITY PLANNING AREA IV, GENERALLY BOUNDED ON THE WEST BY HOME AVENUE, ON THE NORTH BY EUCLID AVENUE, AND ON THE EAST BY RIDGEVIEW DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A and R-2 ZONES AS DEFINED BY SECTIONS 101.0410 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Mid-City Planning
Area IV, generally bounded on the west by Home AVenue,
on the north by Euclid Avenue, and on the east by Ridgeview
Drive, in the City of San Diego, California, within the
boundary of the district designated "R-2A" and "R-2"
on Zone Map Drawing No. <u>C-455.2</u>, filed in the
office of the City Clerk as Document No. <u>753730</u>,
be, and it is hereby incorporated into R-2A and R-2 Zones
as such zones are described and defined by Sections
101.0410 and 101.0409, respectively, of the San Diego
Municipal Code.

Section 2. That Ordinance No. 11060 (New Series), adopted May 10, 1973, and Ordinance No. 8433 (New Series), adopted February 2, 1961, of the Ordinances of The City of San Diego, be and the same are hereby repealed insofar as they conflict herewith.
