AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1,
DIVISION 3 OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 31.0302 RELATING TO LICENSING
TWO OR MORE BUSINESSES AT SAME LOCATION.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter III, Article 1, Division 3 of
the San Diego Municipal Code be and it is hereby amended by
amending Section 31.0302 to read as follows:

SEC. 31.0302 LICENSES--TWO OR MORE BUSINESSES
AT SAME LOCATION

Whenever any person is engaged in two or more retail
businesses at the same location, or in a retail and whole-
sale business at the same location, or has two or more
wholesale businesses at the same location, or has at the
same location a retail business and a business of leasing
goods of the same type as those sold at retail at that
location, such person shall not be required to obtain
licenses for the conducting of each of such businesses,
but shall be issued a joint license, and the average
number of employees of all of such businesses so con-
ducted shall be used as a basis for computing the
amount of license fee to be paid for the conduct of all
such businesses.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.


