BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of CAMINO DEL RIO SOUTH from Texas Street to I-805, in the City of San Diego by widening to a four (4) lane street and installing electrical and communication underground utilities, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned said work to be done under the combined provisions of the California 1911 and 1913 Improvement Acts.
