That the acceptance by the City Manager of that deed of the HILLCREST FREE METHODIST CHURCH OF SAN DIEGO, a California corporation, executed in favor of The City of San Diego, bearing date of October 27, 1974, conveying to said City for park purposes Lot 3, Block 49 of Grantville and Out Lots, according to Map thereof No. 776, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$57,977.20 from Capital Outlay Fund 245 and \$67,102.80 from Park Service District 11382, for a total expenditure of \$125,100 to be used exclusively for the purchase of the above described property, be and the same is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
