
Adopted on JAN 9 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, signed by the Director of the Department of Transportation, executed in favor of The City of San Diego, bearing date of October 21, 1974, conveying to said City for street purposes a portion of Section 35, Township 18 South, Range 2 West, S.B.M., being also State R/W Parcel DD-19095-01-02, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BEYER BOULEVARD.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
