WHEREAS, the Sefton Foundation has generously offered to donate to the Police Department of The City of San Diego a mobile-home type chassis equipped as a Mobile Communications and Command Coordination Van valued at \$24,984.20; and

WHEREAS, existing police communications equipment will be utilized thereby not creating any immediate or initial expenditure of City funds or render necessary the use of City forces or materials exceeding \$500; and

WHEREAS, said donated van will not create an annual maintenance obligation of \$500 or more; and

WHEREAS, it is intended that the van will become City property upon formal acceptance by The City of San Diego; and

WHEREAS, the current command van is a 1967 Ford Vanette which is obsolete and too small for current needs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego be and he is hereby authorized to accept on behalf of said City the generous donation of a mobile-home type chassis equipped as a Mobile Communications and Command Coordination Van from the Sefton Foundation for the Police Department.

2. That this Council, for and on behalf of the citizens of this City, does hereby express its gratitude and publicly commends the Sefton Foundation for this act of civic generosity.
